- (2) to receive the printed English version of all future Corporate Communication only; or

 (4) to receive both the printed English and Chinese versions of all future Corporate Communication.

Otherwise, please affix an appropriate stamp. You may also send email with a scanned copy of the duly completed and signed reply form at singamas.ecom@computershare.com.hk.

If the Company does not receive the duly completed and signed reply form or a response indicating the objection from you by 28 February 2017, then:

- 1) you are deemed to have consented to receive all future Corporate Communication in Website Version; and
- 2) a printed notification letter of the publication of the Corporate Communication on the Company's website will be sent promptly to you at each such publication,

until you inform the Company c/o the Share Registrar otherwise by reasonable prior notice in writing at the above address or by email at singamas.ecom@computershare.com.hk.

You have the right at any time by reasonable notice in writing to the Company c/o Share Registrar (at the above address) or by email at singamas.ecom@computershare.com.hk to change your choice of language and/or means of receipt of the Corporate Communication. Even if you have chosen (or are deemed to have consented) to receive all future Corporate Communication by using electronic means but for any reason have difficulty in receiving or gaining access to the Website Version of the Corporate Communication, the Company will promptly upon receipt of your written request send the Corporate Communication to you in printed form free of charge.
